To All Cement Mason and Plastering Signatory Contractors,

This notice is to remind you of the proper procedures to follow when remitting fringe benefit payments for hours worked by Cement Masons and Plasterers throughout the State of Ohio. All fringe benefit contributions and deductions shall be remitted to the Combined Funds along with the appropriate forms based on the area in which work was performed. If your work was performed in multiple geographic areas during the month this may result in multiple forms being remitted. To assist in this process contact information for each of the Local Unions is attached along with a map of the State reflecting the appropriate geographical jurisdiction.

In order to properly process and timely remit your fringe benefits, it is imperative that you supply us with the following items on each report submitted:

- Description of the agreement you are reporting under, (*such as Local 404 Building Trades, Local 132 Heavy Highway*)
- Work Classification for each employee you are reporting, (*such as Plaster, Cement Mason, Heavy Highway*)
- Individual reports for each work month you are reporting.
- When rates change, separate reports for old rates and new rates.

If there is no work performed in a Local Unions jurisdiction where you are signatory during the month it is recommended to remit a form reflecting "No Hours Worked" or "0 Hours" to avoid any unnecessary delinquency notices/procedures.

Should you need fringe benefit forms for a particular Local Union please contact the Combined Fund or the Local Union office to obtain the necessary forms.

For proper reporting of hours, you should refer to the appropriate Collective Bargaining Agreement or contact the Local Unions in the jurisdiction where the work is being performed.


